22/08. EAST ANGLIAN GREEN ENERGY ENABLEMENT.

National Grid is consulting on proposals to reinforce the high-voltage electricity transmission network between Norwich, Bramford and Tilbury. The proposed reinforcement is around 180km and would comprise mostly overhead line; pylons and conductors.

After crossing into the Braintree district, the preferred corridor continues south west parallel to the north of the A12 and railway. Passing Witham to the south and Silver End to the north before crossing the railway again heading north and continuing west towards the Chelmsford district. Expected reinforcement in this section to be made up of new overhead line supported by steel lattice pylons.

Residents were unanimous in their objections to this proposal and were advised to all respond individually to National Grid and to also write to their MP, County Councillor and Minister of State for Energy, Clean Growth and Climate Change. There is also an online petition that can be signed. The Parish Council will put together a response and publicise it on the Notice Board, Website, Facebook and also put copies in the Cross Keys. There is lots of useful information on the Essex, Suffolk and Norfolk Action Group.
