21/02. APOLOGIES FOR ABSENCE.

21/04. PROGRESS CHECK.

War memorial – the application to Braintree District Council for a grant of £700 was successful.

21/09. PLANNING.

Application Nos: 20/02194/OUT & 21/00471/FUL. Conversion of barn to 2 x 4 bedroom semi-detached dwelling houses with associated parking and amenity space.

Location: Land Adjacent Stanfield Meadow, Vicarage Avenue, White Notley.

The Parish Council had no objections to the 2017 application however there are concerns regarding the outline proposal to demolish the Dutch barn, the proposal to demolish it and replace it with two conventional houses is not in keeping with the existing barn and if granted may set a precedent for further development outside the village envelope.

Application No: 21/00308/HH. Alterations to existing single storey side extension to create two storey side and two storey rear extension.

Location: Plum Tree Cottage, 3 Station Road, White Notley. No objections.

Application No: 21/00752/HH. Proposed two storey side, single storey rear and side car port extension. Alterations to garage roof to form first floor office accommodation.

Location: Fraser Cottage, Pole Lane, White Notley. No objections.

21/10. REMEMBRANCE BENCH.

Request to install a bench in White Notley in memory of a resident that lived in Vicarage Avenue for 65 years. It was agreed to support the erection of a memorial bench on the grass area opposite the school. Permission would need to be obtained from the landowner. Once erected the Parish Council will take responsibility for any future maintenance.
