## 22/41. MINUTES OF THE LAST MEETING.

#### 22/42. PROGRESS CHECK / ACTION PLAN.

#### 22/44. PUBLIC FORUM.

**East Anglian Green Energy Enablement –** consultation runs from 21 April to 16 June 2022.

After crossing into the Braintree district, the preferred corridor continues south west parallel to the north of the A12 and railway. Passing Witham to the south and Silver End to the north before crossing the railway again heading north and continuing west towards the Chelmsford district. Expected reinforcement in this section to be made up of new overhead line supported by steel lattice pylons.

A flyer to be delivered to all homes drawing attention to this consultation. To be included on the agenda for the Annual Assembly in May.
