21/59. APOLOGIES FOR ABSENCE.

Apologies were received from Cllr Fisher.

21/60. MINUTES OF THE LAST MEETING.

The minutes of 27 July 2021 were approved as a correct record of events.

21/61. PROGRESS CHECK / ACTION PLAN.

Station Road – Anglian Water have been out and sampled the leak, it is not sewerage, it is water. They are to look again at the problem.

Play Area Sign – has been ordered.

SID Report – Cllr Bentley produced a report of the traffic speed and volume for The Street, White Notley.

Location: Land adjacent Stanfield Meadow, Vicarage Avenue, White Notley. No objections.

21/66. SPEED INDICATOR DEVICES.

It was agreed to purchase two Speed Indicator Devices from this year's budget. To be finalised at the October meeting. It was agreed to apply for £500 from the District Ward Cllrs Grant Scheme as well as £3,000 from the ECC Locality Fund. A quote to be obtained for the two devices with solar panels.
