10/39. APOLOGIES FOR ABSENCE.

Apologies were received from Cllr Beal.

10/40. MINUTES OF THE LAST MEETING.

The minutes of 15 December 2009 were approved as a correct record of events following one small amendment at 09/37, to change the word 'stop' to 'shelter' (bus shelter). The minutes were then approved as a correct record.

10/41. PROGRESS CHECK.

09/28. The paperwork for adopting the kiosk is now ready to be sent off to BT with the £1.00 adoption fee.
