**MINUTES OF A MEETING OF WHITE NOTLEY AND FAULKBOURNE
PARISH COUNCIL HELD ON TUESDAY 26 JUNE 2018

18/93. APOLOGIES FOR ABSENCE.

Apologies were received from Cllr Daniels, Cllr Fisher and Cllr Guy.

18/94. MINUTES OF THE LAST MEETING.

The minutes of 22 May 2018 were approved as a correct record of events.

18/95. PROGRESS CHECK.

Greenfields have cut the grass in the Village. The Clerk to contact Greenfields to ask them to write to residents who live near the Greensward in Vicarage Avenue asking them not to park on the grass.

18/96. DECLARATION OF INTERESTS.

To receive any Disclosable Pecuniary Interests, Other Pecuniary Interests, or Non-Pecuniary Interests relating to items on the agenda. No interests were declared.

18/97. PUBLIC FORUM.

Planning application 18/00872/FUL was presented to the Council by the member of public present.

18/98. REPORTS.

District Council – apologies were received from Cllr Bebb. Cllr Coleridge gave a report on District Council matters, including an update on the Local Plan which is now back from the Inspectorate, the Plan needs more work before progressing to phase 2. The Town Centre regeneration scheme was also discussed.

County Council – apologies were received from Cllr Abbott.

18/99. PLANNING.

Application No: 18/00872/FUL. Replacement of existing garage and shed with an oak framed garage/ancillary accommodation outbuilding.

Location: Garden House, Church Hill, White Notley. No objections.

Application No: 18/00801/FUL. Demolition of garages and construction of a detached dwelling.

Location: Land rear of Station House, Station Road, White Notley. No objections.

Application No: 18/01019/FUL. Proposed replacement dwelling with associated landscaping.

Location: Green Farm, The Green, White Notley. No objections.

18/00. FRIDAY BUS TO CHELMSFORD.

To hire the BDC Community Bus costs £25.00 a year plus £64.00 per trip. It holds a maximum of 12 people. It was agreed to hire it for a trial period of six months, one trip per month at 10am to leave Chelmsford at 1.45pm. If necessary it will be subsidised by the Parish Council.

18/01. BULB PLANTING.

The 4 Parishes Gardening Club plan to plant daffodil and snowdrop bulbs around the village and are requesting support from the Parish Council. It was agreed to contribute £100.00. A suggested site was the Greensward in Vicarage Avenue. Cllr N Harrison to contact Greenfields to ask for permission.

18/02. VILLAGE CONSULTATION.

Following the Annual Assembly a draft survey/questionnaire has been produced. It was agreed some changes were necessary before it is delivered and to make it clear that the Parish Council cannot promise to deliver everything that is asked for, however all avenues will be considered and feedback provided as to what is or is not possible. A Facebook page will also be looked into.

18/03. SPEED INDICATOR DEVICE (SID).

The battery powered standard option costs £2585 and comes with battery, charger and a secure lockable mounting bracket. Batteries last up to 10 days (dependent on traffic volumes) before needing to be recharged and a spare costs £110. The mains powered version costs £2855 and the solar powered version costs £3235.

Unanimously agreed to purchase a new device.
