District Council – Cllr Bebb gave a report of District Council matters including the budget and a business rates pilot scheme for Essex councils, although as Thurrock are not participating the Council is not confident it will be selected. More planning staff are to be employed to deal with the high number of planning applications. The Council was reminded of the Councillor Community Grants scheme.

County Council – Cllr Abbott informed the Council that County Councillors now have their own named highways officer and reminded the Council that the Highways Panel can still get things done such as signage and speed issues.

18/43. VILLAGE CONSULTATION.

The top issue that came out in the survey was speeding, this will be explored again with Highways. Volunteer drivers for hospital/dental appointments was mentioned. The Council was disappointed in the lack of response from Faulkbourne.

18/44. STREET-LIGHTING IN VICARAGE AVENUE.

Due to the removal of the phone box there have been comments about how dark the area is at the bottom of Vicarage Avenue. The approximate cost for a new light plus connection is $\pounds 2,000.00$.

It was unanimously agreed to install a new street-light.
