Application No: 19/01795/OUT. Demolition of garage and construction of 3 residential units.

Location: Station House, Station Road, White Notley.

It was unanimously agreed to object to this application for the following reasons:

- Unplanned development, the property is outside the Village Envelope.
- If approved it could result in uncontrolled and unplanned expansion of White Notley.
- Safety; Station Road is a heavily used single track road with no pavement for pedestrians and is the only route to the Station.
